I acknowledge that participation in SUAS is a benefit offered to me. I further acknowledge that I have read, understood and voluntarily agree to abide by all of the rules applying to SUAS 2026 (hereafter named "Competition"), including the tenets of the RoboNation Code of Conduct while attending or participating in the Competition. The Competition may include but are not limited to the following: virtual group conversations, interactive sessions in an online platform, and in-person participation at the Competition. In the case of virtual events, all of the terms and conditions of usage, including privacy notices and terms of use, that accompany the websites or links apply.

I understand that my participation in the Competition comes with inherent risks. RoboNation, Skyway Range, its operator Skyway 36, LLC, the Osage Nation, and their officers, directors, agents, and employees (hereafter known as "Releasees") make every effort to minimize potential dangers at the Competition; however, such risks can never be completely eliminated. Participants and related persons should be adequately prepared for potential hazards to persons and/or property involving transiting to and from competition site, transporting equipment, and accidental drowning.

In exchange for the privilege of participating in the Competition, I agree, for myself, my heirs, executors and administrators, to release, indemnify, and hold harmless the Releasees, their staff, contractors, and volunteers from any and all liability, claims, demands, and causes of action whatsoever, including bodily injury resulting from the Competition or anyone administering emergency assistance, and including risk of loss or damage to personal property to me or other participants, arising out of my presence at or participation in the Competition, **WHETHER IT RESULTS FROM THE NEGLIGENCE OF RELEASEES OR ANY OF THEM OR ANY OTHER CAUSE.** I assume full responsibility for any bodily injury and/or property damage arising out of or related to my attendance and/or participation.

I further agree that, if at any time, I feel any activity during the Competition to be unsafe or if I observe unsafe behavior on the part of other participants/observers, I will immediately notify the appropriate Competition official and/or refuse to participate in or observe any further activities. I am aware of the risks and hazards inherent in participating in the Competition, and I elect to voluntarily participate, knowing that participation may entail a risk of injury.

I am fully aware of the risks and potential hazards connected with participating in the Competition, including, but not limited to, risks of physical injury, property damage, drowning, equipment transport, and digital risks such as data breaches, cyberbullying, or unauthorized use of information, and I hereby elect to voluntarily participate in the Competition, and engage in such activity knowing that the activity may be hazardous to my property.

I understand that I am participating in the Competition at my own risk and expense and agree that I will not bring any claim or cause of action of any kind or nature against the Releasees. This waiver, release and discharge does not excuse the Releasees for their liability for intentional harms or for reckless, wanton, or gross negligence.

I understand that failure to abide by this Code of Conduct may result in consequences up to and including warnings, removal from the Competition, disqualification of the team and/or participants, restriction from future RoboNation activities, or referral to appropriate authorities, if required.

- **Compete fairly.** Team products are solely the creation of student participants' own efforts, ideas, and designs with supporting mentors providing only verbal advice.
- **Respect others.** All participants and guests will display courtesy and respect toward officials, volunteers, other teams, and guests of the Competition.
- **Act with integrity.** All participants and guests will behave in a responsible manner and follow the rules of the competition and host organization.
- **Support each other.** All participants will embody the spirit of RoboNation and endeavor to engage with, learn from, and support one another

**Consent to Recording and Photographic Release:** I acknowledge and agree to grant Releasees (including their affiliates and respective employees, directors, volunteers) and assign the right to record, film, live stream, photograph, or capture my likeness in any media now available or hereafter developed and to distribute, broadcast, use, or otherwise globally to disseminate, in perpetuity, such media without any further approval or compensation. The Undersigned on his or her behalf, and on behalf of \_\_\_\_\_, employees, agents, legal representatives and assigns (collectively hereinafter referred to as the "**Undersigned**") hereby RELEASES, WAIVES, AND DISCHARGES the Osage Nation, Osage, LLC and Skyway36, LLC (the "**Released Parties**") from any and all liability, claims, demands, or causes of action that the Undersigned may have for any and all injuries to the Undersigned's person or property, and for damages, including but not limited to, those arising out of the actions of or CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE while the Undersigned is on the property of the Osage Nation, for any purpose or participation in any activity whatsoever.

The Undersigned hereby EXPRESSLY AGREES he, she, or it WILL NOT SUE OR MAKE A CLAIM against the Released Parties for damages or other losses sustained as a result of the Undersigned's presence on or participation in any activity on such property. The Undersigned EXPRESSLY AGREES to not bring unauthorized third parties onto the property of the Released Party; and further agrees to be personally and legally responsible for any unauthorized third parties brought onto the property by them.

The Undersigned further AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Released Parties and each of them from any loss, liability, damage, or cost that the Released Parties may incur due to the presence of the Undersigned. The Undersigned AFFIRMS he, she, or it is currently covered under appropriate general liability and personal health insurance policies issued through a licensed insurance carrier. The Undersigned REPRESENTS AND WARRANTS his, her, or its operation relating to any activity on the property does not violate any federal, state, and/or local laws and ordinances regulating such operation or activity, if any, and the Undersigned has obtained any necessary permits or licenses to engage in such activity if required by law.

The Undersigned EXPRESSLY ACKNOWLEDGES, AGREES, AND UNDERSTANDS the inherent risks and dangers related to the operation of aircraft that no amount of care, caution, instruction, or expertise can eliminate and the Undersigned EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE ENGAGED IN THE OPERATION WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES. The Undersigned further EXPRESSLY AGREES the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the Osage Nation and applicable federal law in which the operation is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF LIABILITY AND CLAIMS, AND UNDERSTANDS THAT THE UNDERSIGNED HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAS SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO HIM, HER, OR IT AND INTENDS THAT THE UNDERSIGNED'S SIGNATURE IS A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
